ou were first introduced to Rachel Bailey, age six, last summer through a story in the local newspaper. Rachel and her sisters Hannah (5) and Sarah (8) had set up a lemonade stand and raised \$13.58. They were recognized for donating the proceeds of their sale to the Northumberland Hills Hospital.

Rachel, a Senior Kindergarten student at Terry Fox Public School, has continued to remember her hospital and just recently presented the Foundation with \$23. What makes this story so special is that she saved \$1 from her allowance each week for 23 weeks – almost $\frac{1}{2}$ year – in order to make this possible!

Rachel's parents, Lisa and Tyler Bailey, are teaching their children the value of managing their money. Each week their daughters receive a \$3 allowance. Their allowance is divided equally between **spending, savings** and **charity**. They also want to teach their daughters that they must have patience and will often have to wait to make a special purchase only after they've saved up enough money.

Rachel decided to donate her charity savings to the hospital to "help buy stuff for the hospital to help the patients", she pointed out. She also indicated that "it's good to help others."

Rachel, it was an absolute pleasure to meet you and the entire hospital family wants to recognize and thank you for choosing the hospital to receive your gift. We promise to spend it wisely and to assure you that "yes" this gift will help our patients.

YOUR DONATIONS AT WORK...JUST LIKE YOU INTENDED

hanks to the wonderful generosity of our donors last fiscal year (March 31, 2011), the Foundation was able to provide the hospital with \$852,677 to purchase essential medical equipment and technology. Below is a list of the equipment purchased in part or in full:

Endoeye scopes (2)

40,890

This is a scope that is used during laparoscopic surgeries which is less invasive. It allows the physician to see in the abdomen without having to open the abdomen with a large incision. There are only small incisions made and the scope and instruments inserted to perform the procedure.

Colonoscopes (2)

82.549

25,033

This is a scope that is used to see inside the colon to identify any abnormalities or disease.

Cystoscopes (2)

This scope is used to see inside the bladder and urinary tract system for any abnormalities or disease.

Patient lift motors (3)

These lifts allow nurses to safely transport patients in and out of bed while reducing the risk of injury to both staff and patients.

Nurse call system

This advanced technological system delivers a message directly to the appropriate nurse carrying a wireless device enabling the nurse to respond quickly to a patient need or request.

HUGS Infant Security System

This is the security system used to prevent abduction of newborns and pediatric patients while they are in hospital.

Tidal CO2 capnometer

Capnography is a non-invasive monitoring technique that allows NHH physicians and staff fast and reliable assessment into the ventilation, circulation, and metabolism of patients. Having this equipment available allows staff in the critical care areas of NHH to more effectively monitor critically ill patients, and provide appropriate care.

Blood coagulation analyzer

The blood coagulation instrument is used for identifying the abnormalities in a patient's blood clotting system by identifying any abnormality which would hinder the blood from clotting which may endanger a patient's life.

Provue automated blood bank system 91,701

The Provue automated blood bank instrument is used to type the patient's blood (e.g. O Positive, A Negative etc.) and allows the laboratory to give the patient the correct blood type when a patient requires it. It also screens for unusual blood group antibodies which may cause transfusion reactions.

Wireless infrastructure expansion

178,931

Hospital-wide expansion of our wireless capabilities is necessary to allow for increased technological advancements including key patient safety initiatives such as patient medication verification.

Picture Archiving Communications System (PACS) Broker

54,889

The Broker is a vital part of the PACS system providing the interface between the Meditech and GE PACS system. If the Broker were to fail causing an unplanned outage, the radiologists would not have access to images for reporting purposes. The current broker has reached its "end of life."

Electronic Health Record -

Document Scanning & Archival

NHH requires an improved system that is less labour-intensive and more effective in storage and retrieval of patient information to support clinical care. This system will make documents which are currently paper based, available in electronic form, thereby allowing multiple clinicians to access them simultaneously from any location.

Computers and other system investments 70,513

Our current electronic (computers, printers, etc.) lifecycle is approximately five (5) years. In order to keep up with increasingly demanding technology, we have implemented an evergreen replacement strategy in which approximately 20% of our electronic equipment is replaced annually.

Sony printer for Operating Room equipment 4,550

This printer is linked with the colonoscope so that pictures can be taken of the colon and printed off for the patient's medical record.

Forward advantage electronic document delivery 5,496 A system to automate the distribution of patient reports to physicians (most responsible physician, family physician, etc.) The current process is manual and labour-intensive. This system will allow us to automatically route reports to the physicians preferred destination – electronic, fax, email or print.

Enterprise wide risk management system 23,311

Computer software to expand the number of users that would have access to this system, which tracks all patient care incidents and complaints. It ensures the hospital adequately tracks and records investigations and resolutions relating to patient care and safety issues.

Bedside medication verification system

A system to help with ongoing safety initiatives in medication delivery by identifying the proper medication for the correct patient through the use of bar-coding technology. This system is integrated with our Meditech patient information system which captures all medications on each patient.

Grateful for the Care



After living most of their married life (41 ¹/₂ years) in Toronto, Ross and Judith (Judy) Butchart retired to the Northumberland area in 2008. In addition to their love of the area and finding a perfect home, they had enjoyed a business connection to the

community and in fact had several other family members already living here.

In April 2010, Judy began to experience discomfort that prompted a visit to Dr. Hameed. After a series of tests, medical specialists were able to make a diagnosis...it was ovarian cancer. Treatment for this disease was swift including a major surgery and chemotherapy treatments in Kingston every four weeks. Unfortunately the cancer was very aggressive. It was on the word of the people at Kingston General Hospital that the Butchart's became aware of the palliative care program at Northumberland Hills Hospital. While initially Judy was cared for at home, it was her request that she be admitted to this unit to spend her final days. Even though Judy was only a patient for two days before succumbing to her cancer, Ross and his son and daughter were impressed with the compassion of the staff. In fact, Ross was grateful for the care of the staff at both Kingston and Northumberland hospitals and in particular, Dr. Moorsam who he remarked that Judy was quite comfortable with.

Northumberland Hills Hospital was there for Judy and her family and Ross noted it's also the hospital for his extended family living in the area. It was his request that donations in memory of Judy be directed to support the continued work of caring for palliative care patients in this community. As a result, over \$5,825 was donated to the hospital.

On behalf of the entire hospital family, we express our deepest appreciation for remembering the hospital and celebrating Judy's life in this way.

Endowment Donation



We are pleased to announce that a distribution of \$55,000 was made to the Hospital from the Foundation's Endowment program. This gift was used to purchase a blood coagulation analyzer for the laboratory.

About the Blood Coagulation Analyzer

The blood coagulation instrument is used for identifying the abnormalities in a patient's blood clotting system. A patient's ability to form a clot to stop the bleeding process depends on a number of sequential steps. If one of those steps develops an abnormality this hinders the blood from clotting and can endanger the patient's life. The blood coagulation analyzer is used to test some of those blood clotting steps and allows the physician to prescribe drugs to help regulate the patient's blood clotting mechanisms.

The number of tests has averaged 15,000 patients per year demonstrating the critical value that this technology and analyzer has provided to the health care within our community. The previous analyzer was ten (10) years old and its useful life had reached its limit.
